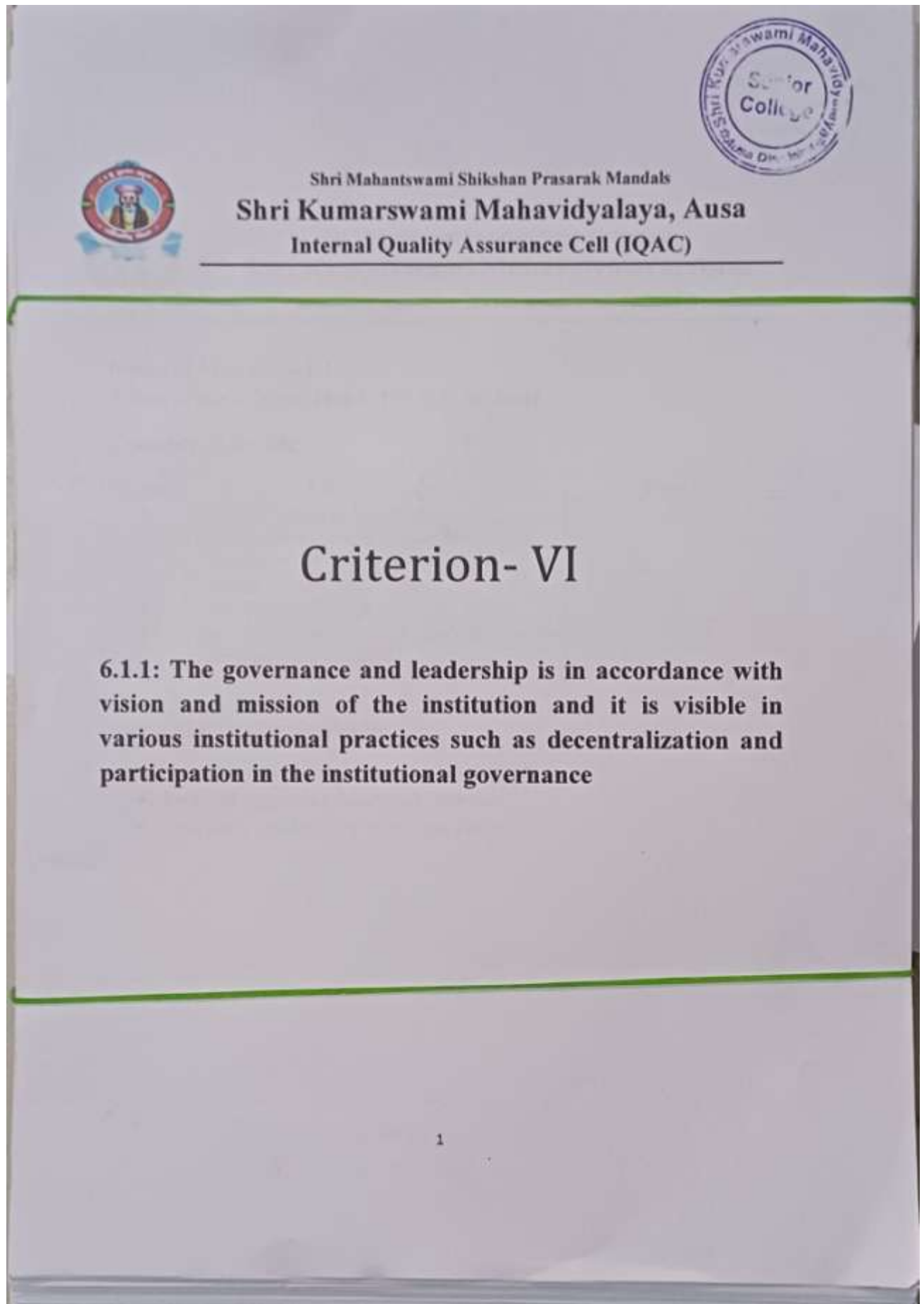


Objective of Anti Sexual & Violence against women Committee
